



CITY OF WILLIAMS LAKE

BYLAW NO. 2389

BEING A BYLAW OF THE CITY OF WILLIAMS LAKE RESPECTING PROPERTY TAX LEVIES FOR THE YEAR ENDING DECEMBER 31, 2023.

WHEREAS pursuant to the provisions of Section 197 of the *Community Charter*, Municipal Councils shall, before the May 15th each year, adopt a Bylaw to impose rates on all taxable land and improvements according to their assessed value to provide the money required for municipal, debt and other purposes.

NOW THEREFORE the Council of the City of Williams Lake, in open meeting assembled, enacts as follows:

1. That this Bylaw may be cited for all purposes as the "City of Williams Lake Tax Rate Bylaw No. 2389, 2023".
2. That "City of Williams Lake Tax Rate Bylaw No. 2359, 2022" is hereby repealed.
3. That the following rates (per thousand dollars of taxable land and improvements) are hereby levied and imposed for the year 2023:
 - (a) For all lawful general purposes of the value of land and improvements taxable for general municipal purposes, rates appearing in column "A" of the Schedule attached hereto and forming a part hereof.
 - (b) For debt purposes of the value of land and improvements taxable for general municipal purposes, rates appearing in column "B" of the schedule attached hereto and forming a part hereof.
 - (c) For the Cariboo-Chilcotin Regional Hospital District purposes on the value of land and improvements taxable for regional hospital district purposes, rates appearing in column "C" of the Schedule attached hereto and forming a part hereof.


- (d) For purposes of the Cariboo Regional District Cariboo Memorial Recreation Complex on the value of land and improvements taxable for regional hospital purposes, rates appearing in column "D" of the schedule attached hereto and forming a part hereof.
 - (e) For the purposes of the Cariboo Regional District on the value of land and improvements taxable for regional hospital purposes, rates appearing in column "E" of the Schedule attached hereto and forming a part hereof.
 - (f) For purposes of the Paratransit Utility Fund on the value of land and improvements taxable for regional hospital district purposes, rates appearing in column "F" of the Schedule attached hereto and forming a part hereof.
4. That the minimum amount of taxation upon a parcel of real property shall be One Dollar (\$1.00).
 5. That this Bylaw shall come into force and take effect upon the date of final adoption by the Council of the City of Williams Lake.


